In accordance with clause 3.10 of our Bylaws, **nominations must be received before midnight on Tuesday, October 8, 2024** and nominations from the floor at the Annual General Meeting will not be accepted. (Nominations can be delivered/mailed to Triathlon Manitoba, 328 – 145 Pacific Ave, Winnipeg, MB, R3B 2Z6; or emailed to [triathlon.ed@sportmanitoba.ca](mailto:triathlon.ed@sportmanitoba.ca).)

Nominations must include the 2024 Elections Nomination Form and a Conflict of Interest Declaration Form. (Clause 7 of our *Conflict of Interest Policy* requires candidates for election to complete the declaration form. The policy can be viewed under “Resources” on [triathlonmanitoba.ca](http://triathlonmanitoba.ca).)

Elections is expected to take place during our Annual General Meeting at 5:30 PM on Tuesday, October 15, 2024 at the Sport Manitoba Building, 145 Pacific Ave, Winnipeg. Any updates to the timing or location for the AGM will be posted on Triathlon Manitoba’s website and social media.

Some things to consider....

Board meetings are on the third Monday of each month (usually cancelled in summer) at 5:30 PM at Sport for Life. They are typically 90 minutes long.

Our *Code of Conduct and Ethics Policy* in part requires Directors to:

“Commit the time to attend meetings and be diligent in preparation for, and in participation in, discussions at ... (Board) meetings;”

“Be independent and impartial and not be influenced by self-interest, outside pressure, expectation of reward, or fear of criticism;” and to

“Exercise the degree of care, diligence, and skill required in the performance of their duties pursuant to the laws under which Triathlon Manitoba is incorporated.”
